ORDER OF CERTIFICATION

Upon a petition duly filed in accordance with Iowa Code section 20.14 and PERB rule, a representative certification election was conducted herein under the direction and supervision of the Board. The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the valid ballots were cast in favor of the affected bargaining unit's representation by AFSCME Iowa Council 61, that no objections to the election were filed as provided for in Iowa Code section 20.15 and PERB rule, and that the employee organization has complied with the relevant requirements of Iowa Code section 20.25.

IT IS THEREFORE ORDERED that AFSCME Iowa Council 61 is hereby designated and certified as the exclusive bargaining representative of the following bargaining unit of employees of the City of Audubon:

INCLUDED: All full and part-time employees, including: Police Officer, Laborer, Deputy City Clerk, Custodian.

EXCLUDED: Police Chief, Director of Public Works, City Clerk, and any others excluded by Iowa Code section 20.4.

ORDER OF DECERTIFICATION

Following the filing of a valid representative decertification petition and its receipt of a disclaimer of representation from the certified employee organization, the Public Employment Relations Board gave public notice of its proposed decision to decertify Over the Road, City Transfer Drivers, Dockmen, Helpers, Warehousemen, Inside Workers, State, County and Municipal Employees, Teamsters 147 as the exclusive bargaining representative of the bargaining unit described below.

No objections to the proposed decision having been filed in accordance with the terms of the public notice and PERB rule, the Board finds that its proposed decision should be finalized.

IT IS THEREFORE ORDERED that Over the Road, City Transfer Drivers, Dockmen, Helpers, Warehousemen, Inside Workers, State, County and Municipal Employees, Teamsters 147 is hereby decertified as the exclusive bargaining representative of the following bargaining unit of employees of the City of Audubon:

INCLUDED: All full-time and regular part-time police officers employed by the employer, City of Audubon, Iowa.

EXCLUDED: Chief of Police, all elected officials, office clerical and all other employees excluded by the Act.


