

ORDER OF CERTIFICATION

The Public Employment Relations Board [Board or PERB] has been advised that an election was conducted pursuant to Order of the Board; that a majority of the ballots were cast for AFSCME/Iowa Council 61, an employee organization; that no objections to the election have been filed, and that said employee organization has complied with all requirements of the Public Employment Relations Act, Chapter 20, Iowa Code (1995) and the Rules thereunder:

IT IS THEREFORE ORDERED that AFSCME/Iowa Council 61 should be, and hereby is, designated and certified by this Board to be the exclusive bargaining representative for employees of Harlan Municipal Utilities, a public employer, in the following bargaining unit:

INCLUDED: All blue, white and technical employees including water plant operator Grades I and II, computer operator, gas crew leader and gas serviceman, journeyman lineman/substation supervisor, journeyman lineman, meter technician II, meter reader, water distribution crew leader/water plant operator III, plant and equipment operator, apprentice journeyman lineman, storekeeper, engineering aide, meter foreman, gas serviceman III.

EXCLUDED: All other employees including general manager, assistant general manager, secretary, purchaser, controller, communications superintendent, water superintendent, meter supervisor/credit manager, gas superintendent, electric line superintendent, acting chief water plant operator, line crew foreman, bookkeeper, all professional employees and all other persons excluded by Section 4 of the Act.
