AMENDMENT OF CERTIFICATION

The Dubuque Building Trades Service Council filed a petition for amendment of certification with the Public Employment Relations Board (PERB) seeking to amend its certification to reflect its name change to "Carpenters Local #678."

The Dubuque Building Trades Service Council is the certified representative of the bargaining unit of Dubuque Community School District employees originally described in PERB Case No. 37 and as amended in PERB Case Nos. 1354 and 1355. It is as follows:

**INCLUDED:** Painters, carpenters, plant maintenance mechanics, electronic repairmen, and groundskeepers.

**EXCLUDED:** All persons excluded by Section 4 of the Act.

A public notice of PERB's proposed decision to grant the requested amendment was issued and posted in accordance with PERB subrule 621-


4.8(2). No objections to the proposed decision were filed within the time specified in that notice.

IT IS THEREFORE ORDERED that the certification of the Dubuque Building Trades Service Council as the exclusive bargaining representative for certain employees of the Dubuque Community School District is hereby amended. The composition of the unit remains unchanged while the certified representative will hereafter be identified as "Carpenters Local #678."


ORDER


