AMENDMENT OF CERTIFICATION

A petition for amendment of certification was filed with the Public Employment Relations Board by the Cherokee County Law Enforcement Association, seeking to amend its certification as the representative of a bargaining unit of employees of Cherokee County which is described as:

INCLUDED: Deputy Sheriffs, Dispatchers, Jailers, Chief Jailer, Secretary.

EXCLUDED: Confidential Secretary, Chief Deputy, Communications Supervisor and Jail Administrator.

The petition sought to substitute the International Union of Operating Engineers, Local 234, in place of the Association as the bargaining unit's certified exclusive representative, due to the Association's merger with Local 234.

A public notice of PERB's proposed decision to grant the requested amendment was issued and posted in accordance with

PERB's rules. No objections to the proposed decision were filed within the time specified in that notice.

IT IS THEREFORE ORDERED that the certification of the Cherokee County Law Enforcement Association as the exclusive bargaining representative for the bargaining unit described above, initially issued in PERB Case No. 3528 and amended in PERB Case Nos. 4686 and 6851, is hereby amended so that the certified representative of the bargaining unit is identified as the INTERNATIONAL UNION OF OPERATING ENGINEERS, LOCAL 234.


