ORDER

INCLUDED: All City employees in the following departments: full and part-time; clerical and non-professional in City Hall; Water Department; Wastewater Department; Public Works Department; and any other personnel that are not in the public safety unit or in the municipal electric utility.

EXCLUDED: City Manager, C.D. Director; Water Superintendent; Waste-water Superintendent; Public Works Superintendent; Confidential employees and all other persons excluded by Section 4 of the Act.

EXCLUDED: City Manager; C.D. Director; Water Supt.; Waste Water Supt.; Public Works Supt.; Power Plant Supt.; Electric Dist. Supt.; Confidential Employees and all other persons excluded by Section 4 of the Act.
