 UNIT AND CERTIFICATION

Upon a petition of amendment of a bargaining unit duly filed pursuant to Iowa Code section 20.13 and PERB rule 621-4.6, the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.

IT IS THEREFORE ORDERED that the bargaining unit of employees of Jackson County, initially determined in Case No. 4966, and the certification of the Jackson County, Iowa, Detention Center Employees Association, are amended to read as follows:

**INCLUDED:** All full-time, part-time, and PRN Employees in the classifications of jailer, civil administrator and civil secretary.

**EXCLUDED:** All other employees.

**ORDER OF CERTIFICATION**



**IT IS HEREBY ORDERED** that Jackson County, Iowa, Detention Center Employees Association, should be, and hereby is, designated and certified by this Board to be the exclusive bargaining representative for employees of Jackson County, a public employer, in the following bargaining unit:

**INCLUDED:** All full and part-time employees which includes jailers, civil administrator and criminal administrator.

**EXCLUDED:** Those employees excluded by Chapter 20 of the Code of Iowa, other certified units and other Jackson County employees not in the included section of this bargaining unit including sworn deputies.
