Upon a petition of amendment of a bargaining unit duly filed pursuant to Iowa Code section 20.13 and PERB rule 621-4.6, the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.

IT IS THEREFORE ORDERED that the bargaining unit of employees of the Johnston Community School District, initially determined in Case No. 500 and amended by Case Nos. 797 and 1202, and the certification of the Johnston Education Support Personnel Association, are amended to read as follows:

INCLUDED: All support staff, including associates, nutrition staff, and custodians.

EXCLUDED: Superintendent, principals, board secretary, administrative secretaries, high school guidance counselor's secretary, all professional employees, enrollment specialist, technology help desk specialist, and all Directors of Support Services and all those excluded by Iowa Code section 20.4.

ORDER




AMENDMENT TO ORDER OF CERTIFICATION
