AMENDMENT OF CERTIFICATION



INCLUDED: All full time and regular part-time professional personnel including but not limited to: Classroom teacher, librarian, school nurse, guidance counselor, departmentalized teacher, title I teacher, remedial teacher, vocational agriculture teacher and any combination of the above.

EXCLUDED: Superintendent, principal, vice principal, assistant principal, administrative assistants, substitute teachers, all other employees and all others excluded by Section 4 of the Act.


