CLARIFICATION OF BARGAINING UNIT AND CERTIFICATION

Upon a petition for clarification of bargaining unit duly filed pursuant to Iowa Code section 20.13 and PERB rule 621-4.6(20), the parties filed with the Board a stipulation of bargaining unit, which was tentatively approved by the Board. A public notice of the Board's proposed decision to alter the description of the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.

IT IS THEREFORE ORDERED that the bargaining unit initially determined in PERB Case No. 6208, and the certification of the Plymouth County Sheriff's Office Employees Association, is amended to provide:

INCLUDED: All full-time and part-time sheriff's Department employees including sergeants, deputy sheriffs, jail administrator, correctional officers, communications dispatchers/supervisors, communications dispatchers, custodial engineer.

EXCLUDED: Sheriff, chief deputy, sheriff's secretary, all supervisors and all others excluded by Iowa Code section 20.4.

ORDER OF CERTIFICATION

Upon a petition duly filed in accordance with Iowa Code section 20.14 and PERB rule, a representative certification election was conducted herein under the direction and supervision of the Board. The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the valid ballots were cast in favor of the affected bargaining unit's representation by the Plymouth County Sheriff's Office Employees Association, that no objections to the election were filed as provided for in Iowa Code section 20.15 and PERB rule, and that the employee organization has complied with the relevant requirements of Iowa Code section 20.25.

IT IS THEREFORE ORDERED that the Plymouth County Sheriff's Office Employees Association is hereby designated and certified as the exclusive bargaining representative of the following bargaining unit of employees of Plymouth County:

INCLUDED: All full and part-time Sheriff's Dept. employees including sergeants, deputy sheriffs, jail administrator, correctional officers, communications dispatchers/supervisors, communication dispatchers.

EXCLUDED: Sheriff, chief deputy, sheriff's secretary, all supervisors and all others excluded by the Act.
