EXCLUDED: The County Engineer, Office Clerk, Assistant to the County Engineer, Inspector No. 1, Inspector No. 2, Maintenance Engineer, Temporary Employees and all other personnel.

AMENDMENT OF CERTIFICATION



ORDER OF CERTIFICATION


