AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20.13 and PERB rule 621-4.6(20), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.

IT IS THEREFORE ORDERED that the bargaining unit of employees of Mitchell County Regional Health Center, initially determined in PERB Case No. 4224, and the certification of PPME Local 2003, is amended to read as follows:

INCLUDED: All regular full-time and regular scheduled part-time employees (employees regularly scheduled to work 16 hours or more per pay period) of the PHO classified as Environmental Services, Switchboard Clerk, Unit Secretary, File Clerk, Admitting/Switchboard Clerk, Cook, Dietary Aide, Linen Coordinator, Lead Environmental Services Tech, Physical Therapy Aide, Lead Cook, Medical Records File Clerk, PHO Receptionist, Sleep Lab Technician, Nurse Aide, Ward Clerk, Pharmacy Tech, Account Specialist, Supply Control Clerk, Optometric Assistant, OR Tech, Pharmacy Tech (Certified), Lab Specimen Collector, Maintenance Assistant, Patient Representative, PHO Transcriptionist, Output Coder/Insurance Specialist, Lab Assistant, Coding Specialist, Certified Medical Assistant, Optometric Assistant (Certified), Financial Services Representative, AP Billing Specialist, Maintenance Technician,


Building/Grounds Tech, Floor Finisher, Specialty Clinic Tech, Limited Radiographer, Lead Output Coder/Insurance Specialist, Coder/URC/SSD, MLT(ASCP), MIS Coordinator, Desktop/Network Services Tech, Physical Therapist Assistant, MT (ASCP), Purchasing Agent, Hospital LPN, Clinic LPN, Registered Radiology Technician, Centralized Scheduler (MA), Health Navigator (MA), Construction Tech, Centralized Scheduler (LPN), Health Manager (LPN), and Surgical Technologist.

EXCLUDED: Managers and supervisors, confidential employees, registered nurses, other professional employees, temporary, PRN and on-call employees.


IT IS HEREBY ORDERED that PPME #2003, should be, and hereby is, designated and certified by this Board to be the exclusive bargaining representative for employees of the Mitchell County Memorial Hospital, a public employer, in the following bargaining unit:

INCLUDED: All regular full-time and regular part-time employees of the Employer classified as licensed practical nurse, nurse aide, operating room technician, laboratory technician, x-ray technician, medical records ART and transcriptionist, dietary worker, housekeeper, laundry and linen, receptionist, insurance clerk, physical therapy aide, and secretarial.

EXCLUDED: Managers and supervisors, confidential employees, registered nurses, other professional employees, non-staff ambulance drivers, temporary, PRN and on-call employees.
