AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20.13 and PERB rule 621-4.6(20), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.

IT IS THEREFORE ORDERED that the bargaining unit of employees of Poweshiek County, initially determined in PERB Case No. 6521, and the certification of Public Professional and Maintenance Employees Local Union 2003, are amended to provide:

INCLUDED: All employees of the Poweshiek County Sheriff's Office including all Deputy Sheriffs, Dispatchers, Jailers, Jailer/Dispatchers, Lead Jailer/Dispatcher, Night Patrol Sergeant and Public Safety Center Custodians.

EXCLUDED: The Sheriff, Chief Deputy, Office Deputy, and Jail Administrator.

ORDER OF CERTIFICATION

Upon a petition duly filed in accordance with Iowa Code section 20.14 and PERB rule, a representative certification election was conducted herein under the direction and supervision of the Board. The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the valid ballots were cast in favor of the affected bargaining unit's representation by Public Professional and Maintenance Employees Local Union 2003, IUPAT, that no objections to the election were filed as provided for in Iowa Code section 20.15 and PERB rule, and that the employee organization has complied with the relevant requirements of Iowa Code section 20.25.

IT IS THEREFORE ORDERED that Public Professional and Maintenance Employees Local 2003, IUPAT, is hereby designated and certified as the exclusive bargaining representative of the following bargaining unit of employees of Poweshiek County:

INCLUDED: All employees of the Poweshiek County Sheriff's Department including all Deputies (contract or otherwise), Dispatchers, Jailers, Jail Administrators and the County Custodians.

EXCLUDED: The Sheriff, Chief Deputy, Office Deputy and Night Patrol Supervisor.
