AMENDMENT OF CERTIFICATION

The Wright County Road Maintenance Employees filed a petition for amendment of certification with the Public Employment Relations Board (PERB) seeking to amend its certification as the representative of a bargaining unit of Wright County employees. The petition proposes the amendment of the certification to reflect the Wright County Road Maintenance Employees' merger into Public Professional & Maintenance Employees, Local 2003.

A public notice of PERB's proposed decision to grant the requested amendment was issued and posted in accordance with PERB subrule 621-4.8(2). No objections to the proposed decision were filed within the time specified in that notice.

IT IS THEREFORE ORDERED that the certification of the Wright County Road Maintenance Employees as the exclusive bargaining representative for certain employees of Wright

County, described in PERB Case No. 935, is hereby amended. The composition of the unit remains unchanged while the certified representative will hereafter be identified as PUBLIC PROFESSIONAL & MAINTENANCE EMPLOYEES, LOCAL 2003.

EXCLUDED: Engineer, Assistant Engineer and all other County employees and all employees excluded by Section 4 of the Act.
