AMENDMENT OF CERTIFICATION

Sioux City Policemen's Association filed a petition for amendment of certification with the Public Employment Relations Board (PERB) seeking to amend its certification as the representative of a bargaining unit of Sioux City employees. The petition proposes the amendment of the certification to reflect Sioux City Policemen's Association name change to **Sioux City Police Officers Association.**

A public notice of PERB's proposed decision to grant the requested amendment was issued and posted in accordance with PERB subrule 621-4.8(2). No objections to the proposed decision were filed within the time specified in that notice.


IT IS THEREFORE ORDERED that the certification of Sioux City Policemen's Association as the exclusive bargaining representative for certain employees of Sioux City, originally described in PERB Case No. 537 is hereby amended. The composition of the unit remains unchanged while the certified

representative will hereafter be identified as **Sioux City Police Officers Association.**

NOW on this 3rd day of May 1976, the Board being advised that an election was conducted pursuant to Order of the Board, and that Sioux City Policemen's Association an employee organization, received an affirmative vote of the majority of employees in the bargaining unit, and the Board having further found that the employee organization has fully complied with all regulations of the Act and the rules and regulations thereunder,

IT IS HEREBY ORDERED BY THE BOARD that Sioux City Policemen's Association should be, and hereby is, designated and certified by this Board to be the exclusive bargaining representative for the employees of City of Sioux City, Iowa a public employer, in the

following bargaining unit:

INCLUDED: All regular sworn members of the Sioux City Police Department including the position classifications of Police Officer, Police Sergeant, and Police Lieutenants.

EXCLUDED: The following position classifications are excluded from the unit: Chief of Police, Assistant Chief of Police, and Police Captain.
