AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

Upon a petition for amendment of bargaining unit duly filed pursuant to PERB rule 621-4.6(20), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation, contingent upon the conduct of a representative certification election among the employees to be added to the unit, was posted in conformance with PERB's rules. No objections to the proposed decision were filed.

A representative certification election having subsequently been conducted among the employees proposed for addition to the unit, and a majority of the valid votes having been cast in favor of their representation by the certified employee organization, the Board finds that an order amending the bargaining unit should be entered.

IT IS THEREFORE ORDERED that the bargaining unit of employees of the City of Jesup initially determined in PERB Case No. 5078, and the certification of Chauffeurs, Teamsters and Helpers, Local 238, are amended to provide:

INCLUDED: All regular full-time and part-time employees.

EXCLUDED: Chief of Police, City Clerk, Public Works Director, and all others excluded by Iowa Code section 20.4

ORDER OF CERTIFICATION

The Public Employment Relations Board [Board or PERB] has been advised that an election was conducted pursuant to Order of the Board; that a majority of the ballots were cast for Chauffeurs, Teamsters and Helpers, Local 238, an employee organization; that no objections to the election have been filed, and that said employee organization has complied with all requirements of the Public Employment Relations Act, Chapter 20, Iowa Code (1993) and the Rules thereunder:

IT IS HEREBY ORDERED that Chauffeurs, Teamsters and Helpers, Local 238, should be, and hereby is, designated and certified by this Board to be the exclusive bargaining representative for employees of the City of Jesup, a public employer, in the following bargaining unit:

INCLUDED: All regular full-time police officers of the City of Jesup Police Department.

EXCLUDED: Chief of Police, confidential employees, employees of other City departments and all others excluded by Section 20.4 of the Act.
