**IT IS HEREBY ORDERED** that the bargaining unit previously determined in Case No. 1024 and amended in Case No. 3550, and the certification of Chauffeurs, Teamsters & Helpers, Local #238, is amended to read as follows:

**INCLUDED:** Regular full-time and regular part-time bus drivers, body repairmen and dispatchers employed by the District of the transportation garage.

**EXCLUDED:** All mechanics, all other employees of the District, supervisory and confidential personnel as defined by the Act and all other persons excluded by the Act.

ORDER OF CERTIFICATION


