AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20.13 and PERB rule 621-4.6(20), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.

IT IS THEREFORE ORDERED that the bargaining unit of employees of the Waukee Community School District initially determined in PERB Case No. 8266, and the certification of Teamsters Local 238, are amended to provide:

INCLUDED: All full-time and part-time employees in the following job classifications: Food Service Worker, Food Service Clerk, Food Service Head Cook, Food Service Grill Line, Food Service Van Driver and Floating General Worker/Cashier.

EXCLUDED: Director of Nutrition, Food Service District Supervisors, Food Service Supervisors, Food Service Tech Support, Food Service Administrative Assistants and all other employees excluded by Iowa Code section 20.4.

IT IS THEREFORE ORDERED that Teamsters Local 238 is hereby designated and certified as the exclusive bargaining representative of the following bargaining unit of employees of the Waukee Community School District:


