AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20.13 and PERB rule 621-4.6(20), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.

IT IS THEREFORE ORDERED that the bargaining unit initially determined in PERB Case No. 2922 and the amendment of certification in PERB Case No. 4841 of the United Automobile, Aerospace and Agricultural Workers of America (UAW), Local #74, is amended to provide:

INCLUDED: Employees in the classifications of Police Officer and Secretary in the Police Department for the City of Albia, Iowa.

EXCLUDED: Supervisors, all other City employees and those excluded by Section 4 of the Act.

AMENDMENT OF CERTIFICATION




