ORDER OF RECERTIFICATION

Following the filing of an order directing an election, the Public Employment Relations Board (Board) conducted a retention and recertification election pursuant to Iowa Code section 20.15(2). The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying AFSCME Iowa Council 61 (Food Service) as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election were filed as provided for in Iowa Code section 20.15(4) and PERB rule 621-15.4 and no postelection challenges were filed pursuant to PERB subrule 15.2(4). Therefore, the Board finds that an order of recertification should be issued.



INCLUDED: All cafeteria employees in the Davenport Community School District as follows all full-time and regular part-time school food service workers, cooks, head cooks, head bakers, bakers, bakers assistants, servers, cashiers, dishwashers and van drivers.

EXCLUDED: Food service managers, educational aides, clerical staff, substitutes, Food Service Director, director's secretary and all other employees excluded by section 4 of the Act.


