Upon a petition duly filed in accordance with Iowa Code section 20.14 and PERB rule, a representative certification election was conducted herein under the direction and supervision of the Board. The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the valid ballots were cast in favor of the affected bargaining unit's representation by AFSCME Iowa Council 61, that no objections to the election were filed as provided for in Iowa Code section 20.15(4) and PERB rule 5.4(2), and that the employee organization has complied with the relevant requirements of Iowa Code section 20.25.

IT IS THEREFORE ORDERED that AFSCME Iowa Council 61 is hereby designated and certified as the exclusive bargaining representative of the following bargaining unit of employees of the City of Estherville:

Said stipulation having been tentatively approved by the Board and the Board having no objections;


ORDER
