EXCLUDED: Financial Services Officer, Vocational Services Coordinator, Vocational specialist, Vocational Technicians, Activities and Living Skills Assistant I, Activities and Living Skills Assistant II, Nutritional assistant, Nursing Services Coordinator, Group Home Supervisors, Apartment Supervisors, Home Care Specialist, Case Coordinators, Managers, Supervisors, confidential and other employees excluded by Section 20.4 of the Act.


