ORDER OF RECERTIFICATION

Following the filing of an order directing an election, a retention and recertification election pursuant to Iowa Code section 20.15(2) was conducted under the supervision of the Board. The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying Alburnett Education Association as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election having been filed as provided for in Iowa Code section 20.15(4) and PERB rule 621-5.4, the Board finds that an order of recertification should be issued.

IT IS THEREFORE ORDERED that Alburnett Education Association is hereby recertified as the exclusive bargaining representative of the following bargaining unit of employees of Alburnett Community School District:

INCLUDED: All full-time and regular part-time professional employees classroom teachers, librarian, guidance counselor and special education teachers.

EXCLUDED: Superintendents, principals, nurse, secretaries, custodians, cooks, teacher aides, bus drivers and all other persons excluded by section 4 of the Act.

Said stipulation having been tentatively approved by the Board and the Board having no objections,


ORDER
