AMENDMENT OF CERTIFICATION

The Alta Education Association filed a petition for amendment of certification with the Public Employment Relations Board (PERB) seeking to amend its certification to reflect its renaming to Alta-Aurelia Education Association and, also to reflect the renaming of the public employer to Alta-Aurelia Community School District.

The Alta Education Association is the certified representative of the bargaining unit of Alta Community School District employees originally described in PERB Case No. 976 with a subsequent recertification in PERB Case NO. BU-0038. The current unit description is as follows:

INCLUDED: All full-time and regular part-time professional personnel including Classroom teachers, guidance counselor, Librarian, Departmentalized teacher Remedial Reaching teacher, Vocational Homemaking teacher, and Vocational Agriculture teachers.

EXCLUDED: Superintendent, principals, nurse, athletic director, administrative aide and all others excluded by Section 4 of the Act.

A public notice of PERB's proposed decision to grant the requested amendment was issued and posted in accordance with PERB subrule 621—

4.8(2). No objections to the proposed decision were filed within the specified time specified.

IT IS THEREFORE ORDERED that the certification of the Alta Education Association as the exclusive bargaining representative for certain employees of the Alta Community School District, described in PERB Case No. 976, and as recertified in BU-0038, is hereby amended. The composition of the unit remains unchanged while the Association will hereinafter be identified as "**Alta-Aurelia Education Association**" and the public employer will hereafter be identified as "**Alta-Aurelia Community School District.**"

ORDER OF RECERTIFICATION

Following the filing of an order directing an election, a retention and recertification election pursuant to Iowa Code section 20.15(2) was conducted under the supervision of the Board. The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying Alta Education Association as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election having been filed as provided for in Iowa Code section 20.15(4) and PERB rule 621—5.4, the Board finds that an order of recertification should be issued.

IT IS THEREFORE ORDERED that Alta Education Association is hereby recertified as the exclusive bargaining representative of the following bargaining unit of employees of Alta Community School District:

INCLUDED: All full-time and regular part-time professional personnel including Classroom teachers, guidance counselor, Librarian, Departmentalized teacher Remedial Reading teacher, Vocational Homemaking teacher, and Vocational Agriculture teachers.

EXCLUDED: Superintendent, principals, nurse, athletic director, administrative aide and all others excluded by Section 4 of the Act.

ORDER OF CERTIFICATION


