ORDER OF CERTIFICATION

Upon a petition duly filed in accordance with Iowa Code section 20.14 and PERB rule 621—4.3(20), a representative certification election was conducted herein under the direction and supervision of the Public Employment Relations Board. The Board, having subsequently reviewed the file and being fully advised of the premises, finds that a majority of the eligible voters cast a vote in favor of the affected bargaining unit's representation by Arnolds Park City Employees, that no objections to the election were filed as provided for in Iowa Code section 20.15 and PERB rule 621—5.4(20), and that the employee organization has complied with the relevant requirements of Iowa Code section 20.25.



Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20.13 and PERB rule 621-4.6(20), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.

IT IS THEREFORE ORDERED that the bargaining unit of employees of the City of Arnolds Park, initially determined in PERB Case No. 4851, and the certification of Arnolds Park City Employees, are amended to provide:

**INCLUDED:** Street Superintendent, Street Maintenance Worker, Water Superintendent, full-time Police Officers, Assistant Police Chief, Office Secretary, and Utility Clerk.

**EXCLUDED:** City Administrator, Deputy City Clerk, Police Chief, Seasonal Park Employees, Seasonal Police Officers, and part-time employees.


