ORDER OF RECERTIFICATION

Following the filing of an order directing an election, a retention and recertification election pursuant to Iowa Code section 20.15(2) was conducted under the supervision of the Board. The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying Boone Police Bargaining Unit as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election having been filed as provided for in Iowa Code section 20.15(4) and PERB rule 621-5.4, the Board finds that an order of recertification should be issued.


IT IS THEREFORE ORDERED that Boone Police Bargaining Unit is hereby recertified as the exclusive bargaining representative of the following bargaining unit of employees of City of Boone:

INCLUDED: Captain; Patrolman; Records Clerk; Senior Dispatcher; and Dispatchers.

EXCLUDED: Chief and Assistant Chief of Police; Parking Attendant,; and all other City Employees, and all those excluded by Section 4 of the Act.
