

AMENDMENT OF CERTIFICATION

The Public Employment Relations Board filed an agency-initiated petition seeking to amend the certification of Service Employees International Union, Local 199 (SEIU), to reflect the change in the public employer's name to "Central DeWitt Community School District."

SEIU is the certified representative of the bargaining unit of school district employees (custodial), originally described in PERB Case No. 588. There were subsequent amendments in certification for changes in the employee organization's name in Case Nos. 5213 and 6140. The unit is described as follows:

INCLUDED: Matrons and Custodians.

EXCLUDED: Professional, and non-professional which includes Teachers, Secretaries, Aides, Bud Drivers, Cooks, The Director of Buildings and Grounds and his Assistant, all Mechanics and all Administrators.

The composition of the unit remains unchanged. A public notice of PERB's proposed decision to grant the requested amendment was issued and posted in accordance with PERB subrule 621-4.8(2). No objections to the proposed decision were filed within the specified time.

IT IS THEREFORE ORDERED that the certification of SEIU as the exclusive bargaining representative for certain employees of the Central DeWitt Community School District, successor to the Central Clinton Community School District, is hereby amended. The public employer will hereafter be identified as "Central DeWitt Community School District."
