

AMENDMENT OF CERTIFICATION

There have been no previous amendments to the certification. The description of the unit [SIC], as contained in Case No. 589, provides:

The composition of the unit remains unchanged. A public notice of PERB's proposed decision to grant the requested amendment was issued and

posted in accordance with PERB subrule 621-4.8(2). No objections to the proposed decision were filed within the specified time.

IT IS THEREFORE ORDERED that the certification of Central School Food Service Association as the exclusive bargaining representative for certain employees of the Central DeWitt Community School District, successor to the Central Clinton Community School District, is hereby amended. The public employer will hereafter be identified as "Central DeWitt Community School District."


