ORDER OF RECERTIFICATION

Following the filing of an order directing an election, the Public Employment Relations Board (Board) conducted a retention and recertification election pursuant to Iowa Code section 20.15(2). The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying Des Moines Police Bargaining Unit Association as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election were filed as provided for in Iowa Code section 20.15(4) and PERB rule 621–15.4(20), and no postelection challenges were filed pursuant to PERB subrule 621—15.2(4). Therefore, the Board finds that an order of recertification should be issued.

IT IS THEREFORE ORDERED that Des Moines Police Bargaining Unit Association is hereby recertified as the exclusive bargaining representative of the following bargaining unit of employees of City of Des Moines:

INCLUDED: All "sworn" members of the Police Department including Patrolman, Master Patrolman, Detective Woman, Police Matron.

EXCLUDED: Police Chief, Assistant Police Chief, Police Captain, Police Lieutenant, Police Sergeant and all "non-sworn" employees.

No objections to the election having been filed as provided for in Iowa Code section 20.15(4) and PERB rule 621-5.4, the Board finds that an order of recertification should be issued.



OF CERTIFIED EMPLOYEE ORGANIZATION


