ORDER

IT IS HEREBY ORDERED that the bargaining unit previously determined in case number 419 and the certification of the Dubuque Association of Educational Secretaries and Associates in that case be and hereby are ammended to read as follows:

INCLUDED: All full-time and regular part-time Teacher Associates and Secretaries of the Employer including Learning Resource Center, ESEA Title I, Clerical, IDT, Lounge Supervision, Business Education Lay Readers, Locker Bay Supervision, Special Education, Health Aides, Noon Duty, Crossing Guard, Auditorium, Extension School Teacher Aides and Library Typist, Learning Resource Secretary, Account Clerk II, Athletic Director's Secretary, Health Services Secretary, Switchboard/MultilithOperator, Accounts Payable Clerk, Attendance, Records Secretaries, Maintenance Secretary, and Certified Occupational Therapy Assistants.
