ORDER OF RECERTIFICATION

Following the filing of an order directing an election, the Public Employment Relations Board (Board) conducted a retention and recertification election pursuant to Iowa Code section 20.15(2). The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying PPME Local 2003 (Mixed) as the exclusive bargaining representative of the bargaining unit described below.

PROPOSED DECISION AND ORDER

This matter concerns Public, Professional & Maintenance Employees, Local 2003's petition for clarification of bargaining unit filed pursuant to Public Employment Relations Board rule 621-4.7(20). The petition seeks to clarify whether substitute bus drivers employed by the Saydel Community School District are within the bargaining unit represented for purposes of collective bargaining by Local 2003.

An evidentiary hearing on the petition was conducted before me in Des Moines, Iowa, on August 5, 1999. Both parties were represented by counsel, Matthew Glasson for Local 2003 and Brian Gruhn for the District. Pursuant to section 17A.14(3),¹ official notice was taken of the official PERB files reflecting the organizational history of the bargaining unit in issue.

FINDINGS OF FACT

The history of the bargaining unit in question, although extensive, is clear from the officially noticed PERB documents.


the parties' treatment of substitutes as included before 1991), I cannot agree that since the parties (or at least PPME) did not intend the consolidation to exclude any previously represented employees, such could not have been its effect.

Having examined the entire record, and finding no persuasive evidence that substitute drivers have traditionally been treated by the parties as within the present bargaining unit or the existence of any other factor indicative of their inclusion, I necessarily conclude that substitute drivers are not and have not been in the presently constituted bargaining unit. I consequently propose entry of the following clarification:

ORDER

Substitute bus drivers employed by the Saydel Community School District are not included within the bargaining unit described in PERB Case No. 4575, but instead fall within that unit's "all other employees of the District" exclusion.




