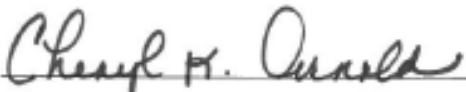

AMENDMENT OF CERTIFICATION






