ORDER OF RECERTIFICATION

Following the filing of an order directing an election, the Public Employment Relations Board (Board) conducted a retention and recertification election pursuant to Iowa Code section 20.15(2). The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying AFSCME Iowa Council 61 (Security) as the exclusive bargaining representative of the bargaining unit described below.

PROPOSED DECISION AND ORDER

James H. Murphy, Administrative Law Judge. In this case the American Federation of State, County and Municipal Employees, Iowa Council 61, (hereinafter AFSCME), has filed a petition for amendment of bargaining unit pursuant to section 13 of the Public Employment Relations Act (Act), Chapter 20, Code of Iowa (1989).

The matter was set for hearing, and heard before me in the offices of the Public Employment Relations Board (PERB) on September 6, 1990. Through its amendment of bargaining unit petition, AFSCME seeks the inclusion of the job classification "Correctional Supervisor I" (hereinafter CSI), within the bargaining unit it has been certified to represent.

At hearing AFSCME was represented by its general counsel, Michael E. Hansen, and the State of Iowa was represented by Michael K. Elliott, attorney for the Iowa Department of Personnel. Both parties were provided an opportunity to present evidence and arguments at hearing. Both parties waived the filing of post hearing briefs.

The evidence in this case clearly shows that the CSI's supervisory responsibility is substantial and persuasive enough to make the CSI classification a part of management.



REISSUED DECISION ON APPEAL<sup>1</sup>

STATEMENT OF THE CASE

This case concerns an appeal by the State of Iowa (State) of a proposed decision and order issued by an administrative law judge (ALJ) on July 3, 1989 in case numbers 3507 and 3513.

<sup>1</sup>Following the issuance of our Decision on Appeal herein on October 17, 1989, the Public Employer/Respondent commenced a judicial review proceeding pursuant to section 17A.19, Code of Iowa (1989), alleging that certain statements contained in that Decision were erroneous. The language complained of consisted of comments concerning the analysis of the Administrative Law Judge who issued the Proposed Decision and Order herein and the arguments of the Public Employer/Respondent on appeal, and was neither essential nor necessary to our determination of the merits of the case. Although disagreement concerning the correctness of that dicta continues, the parties and the Board have agreed to the issuance of this Reissued Decision on Appeal, with the aforementioned dicta excised, as a means of informally resolving the pending judicial review proceeding. Such reissuance is not, however, to be construed as any acknowledgement by the Board or any party of the correctness of any other's position concerning the substance of the excised language. Since this Reissued Decision on Appeal supercedes and replaces the original Decision on Appeal herein, subscribers to the PERB Information Service should discard the October 17, 1989 Decision on Appeal and substitute this Reissued Decision in its place.

In this case, the American Federation of State, County, and Municipal Employees, Iowa Council 61 (AFSCME) filed a petition for amendment of bargaining unit (Case No. 3507) pursuant to section 13 of the Public Employment Relations Act (Act), ch. 20 Code of Iowa (1987). AFSCME also filed a prohibited practice complaint (Case No. 3513) against the State pursuant to section 11 of the Act. The cases were consolidated for hearing before the ALJ. In his proposed decision in Case No. 3507, the ALJ determined that the bargaining unit should be amended to specify the inclusion of the job classification of "Security Guard III". In Case No. 3513, the ALJ determined that the State violated sections 10(1) and 10(2)(e) of the Act in connection with its creation of the "Security Guard III" classification and its refusal to treat the new classification as included within the bargaining unit.

On July 14, 1989, the State appealed the determinations made by the ALJ in both Case Nos. 3507 and 3513 to the Public Employment Relations Board (PERB or Board) pursuant to section 11.2 of the Act. Oral arguments on appeal were presented to the Board on August 16, 1989 in Des Moines, Iowa by the State's representative, S. Fae Brown-Brewton, and by AFSCME's attorney, Michael E. Hansen. Both parties filed briefs on appeal by September 7, 1989.

At the hearing on appeal, AFSCME moved to cross-appeal the ALJ's decision on the ground that the ALJ failed to find an additional violation of section 20.10(2)(d) of the Act. Pursuant to PERB Rule 9.1, however, AFSCME's motion to cross-appeal was untimely, and is hereby denied.

provisions of the federal statute. We conclude that the State violated sections 10.1 and 10.2(e) of the Act by refusing to apply terms of the contract, specifically the dues deductions provisions, to Security Guard IIIs in the mistaken belief that changes in their duties and/or titles rendered them excluded from the unit.

In the present case, although AFSCME had a right, upon request, to bargain the pay grade for the new Security Guard III position unilaterally established by the State, we conclude that AFSCME waived that right. When notified of the proposed new classification, AFSCME did not request to bargain the particulars of the terms of the new classification, apparently because AFSCME was satisfied with the pay grade established by the State. The State violated sections 10.1 and 10.2(e) of the Act, however, by refusing to apply contract terms, specifically, the dues deduction provisions of the contract, to the new classification, and AFSCME promptly acted to protect its rights in this regard by filing the instant complaint.

Accordingly, based on all of the above, we conclude that the State violated sections 10.1 and 10.2(e) by its actions. In order to remedy the prohibited practices found, we issue the following:


#### ORDER

The Order of Certification of AFSCME/Iowa Council 61, and the State of Iowa security bargaining unit determined by PERB in Case No. 942 are hereby clarified and amended to specifically include the job classification of Security Guard III.

In order to remedy the prohibited practices found to have occurred, the State shall cease and desist from excluding Security Guard IIIs from coverage of the collective bargaining agreement, and shall immediately post copies of the attached Notice to Employees at the Woodward State Hospital-School, in places customarily used for the posting of notices to employees, for a period of not less than thirty (30) calendar days.



## DECISION AND ORDER


