ORDER OF RECERTIFICATION

Following the filing of an order directing an election, the Public Employment Relations Board (Board) conducted a retention and recertification election pursuant to Iowa Code section 20.15(2). The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying Teamsters Local 238 (Mixed) as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election were filed as provided for in Iowa Code section 20.15(4) and PERB rule 621–15.4(20), and no postelection challenges were filed pursuant to PERB subrule 621—15.2(4). Therefore, the Board finds that an order of recertification should be issued.

IT IS THEREFORE ORDERED that Teamsters Local 238 (Mixed) is hereby recertified as the exclusive bargaining representative of the following bargaining unit of employees of Wapello County:

INCLUDED: All White Collar and Blue Collar Employees of Wapello County working in the Treasurer's office, the Auditor's office, the Recorder's office, the Attorney's office and the CPC office.

EXCLUDED: Elected Officials, Deputies, Chief Executive Officers, Supervisors, Confidential employees and others excluded by the Act.


