AMENDMENT OF CERTIFICATION

The Carter Lake Peace Officers Association filed a petition for amendment of certification with the Public Employment Relations Board (PERB) seeking to amend its certification as the representative of a bargaining unit of City of Carter Lake employees. The petition proposes the amendment of the certification to reflect the Carter Lake Peace Officers Association's merger into General Drivers and Helpers Union, Local 554.

A public notice of PERB's proposed decision to grant the requested amendment was issued and posted in accordance with PERB subrule 621-4.8(2). No objections to the proposed decision were filed within the time specified in that notice.

IT IS THEREFORE ORDERED that the certification of the Carter Lake Peace Officers Association as the exclusive bargaining representative for certain employees of the City of

Carter Lake, described in PERB Case No. 4019, is hereby amended. The composition of the unit remains unchanged while the certified representative will hereafter be identified as GENERAL DRIVERS AND HELPERS UNION, LOCAL 554.
