No objections to the election having been filed as provided for in Iowa Code section 20.15(4) and PERB rule 621-5.4, the Board finds that an order of recertification should be issued.



The composition of the unit remains unchanged.

A public notice of PERB's proposed decision to grant the requested amendment was issued and posted in accordance with PERB subrule 621-4.8(2). No objections to the proposed decision were filed within the specified time specified.

IT IS THEREFORE ORDERED that the certification of the Area Education Agency 267 Education Association as the exclusive bargaining representative for certain employees of Central Rivers Area Education Agency, successor to the Area Education Agency 267, is hereby amended. The certified employee organization will hereafter be identified as "**Central Rivers Education Association**" and the public employer will hereafter be identified as "**Central Rivers Area Education Agency.**"

AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

A combined petition for amendment of bargaining unit and amendment of certification was filed with the Public Employment Relations Board pursuant to PERB rules 621-4.6 and 621-4.8. The petition results from the reorganization of the Northern Trails Area Education Agency, Area Education Agency 6 and Area Education Agency 7 into the Area Education Agency 267, the renaming of the Area Education Agency 7 Education Association as the Area Education Agency 267 Education Association, the elimination of the Northern Trails Education Association and the Area Education Agency 6 Employees' Organization and the parties' desire to amend the description of the bargaining unit employed by the AEA 7, into which employees of the Northern Trails AEA and AEA 6 are accreted pursuant to Iowa Code section 273.22(2), and which will thereafter be employed by the new Area Education Agency 267.

A public notice of PERB's proposed decision to grant the requested amendments was issued and posted in accordance with PERB rules. No objections to the proposed decision have been filed within the time specified in such notice, and the Area Education Agency 267 Education Association has complied with the relevant requirements of Iowa Code section 20.25.

IT IS THEREFORE ORDERED that the certification of the Area Education Agency 7 Education Association as the exclusive bargaining representative for certain employees of the AEA 7 issued in PERB Case No. 338 as amended in PERB Case Nos. 2969 and 3077, is hereby amended to reflect its successor, the AREA EDUCATION AGENCY 267 EDUCATION ASSOCIATION, as the certified bargaining representative for the following-described unit of

employees of the Area Education Agency 267, the successor to the Northern Trails, Area 6 and Area 7 Area Education Agencies. The Northern Trails Education Association certified in PERB Case No. 1802 is hereby eliminated. The Area Education Agency 6 Employees' Organization certified in PERB Case No. 760 as amended in PERB Case Nos. 1330, 2070, and 2432 is hereby eliminated.

IT IS FURTHER ORDERED that the description of the bargaining unit of employees of the Area Education Agency 7 originally determined in PERB Case No. 338 as amended in PERB Case Nos. 2969 and 3077 and now represented by the Area Education Agency 267 Education Association, is amended to provide:




