AMENDMENT OF CERTIFICATION

The Public Employment Relations Board filed an agency-initiated petition seeking to amend the certification of Central Iowa Landfill Employees Council to reflect the change in the public employer's name to "Metro Waste Authority."

Central Iowa Landfill Employees Council is the certified representative of the bargaining unit of public employees originally described in PERB Case No. 45. The unit has not been amended and is described as follows:

**INCLUDED:** All laborers, equipment operators, maintenance employees and gate attendants at the Employer's Solid Waste Landfill in Polk County, Iowa.

**EXCLUDED:** Office clerical employees, professional employees, supervisors and all other persons excluded by Section 4 of the Act.

The composition of the unit remains unchanged. A public notice of PERB's proposed decision to grant the requested amendment was issued and posted in accordance with PERB subrule 621-4.8(2). No objections to the proposed decision were filed within the specified time.

IT IS THEREFORE ORDERED that the certification of Central Iowa Landfill Employees Council as the exclusive bargaining representative for certain employees of the Metro Waste Authority, successor to the Metropolitan Solid Waste Agency, is hereby amended. The public employer will hereafter be identified as "Metro Waste Authority."

ORDER OF CERTIFICATION

NOW on this 7th day of November 1975, the Board being advised that an election was conducted pursuant to Order of the Board, and that Central Iowa Landfill Employees Council, an employee organization, received an affirmative vote of the majority of employees in the bargaining unit, and the Board having further found that the employee organization has fully complied with all regulations of the Act and the rules and regulations thereunder,

IT IS HEREBY ORDERED BY THE BOARD that Central Iowa Landfill Employees Council should be, and hereby is, designated and certified by this Board to be the exclusive bargaining representative for the employees of Metropolitan Solid Waste Agency a public employer, in the following bargaining unit:

INCLUDED: All laborers, equipment operators, maintenance employees and gate attendants at the Employer's Solid Waste Landfill in Polk County, Iowa.

EXCLUDED. Office clerical employees, professional employees, supervisors and all other persons excluded by Section 4 of the Act
