AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

A petition for amendment of certification was duly filed under Rule 4.8 of the Public Employment Relations Board [Board or PERB] Rules. Said petition has been tentatively approved by the Board; a Public Notice of Proposed Decision of Amendment of Certification has been posted in conformance with PERB rules; and no objections have been filed. The parties' joint petition results from the reorganization of the Guttenberg and Garnavillo Community School Districts into the Clayton Ridge Community School District. Therefore:

IT IS THEREFORE ORDERED that the certification of the Guttenberg Education Association, issued in Case No. 255, is amended to reflect the change of its name to the "Clayton Ridge Education Association" and its status as the certified bargaining representative of a bargaining unit of employees of the new Clayton Ridge Community School District. The Garnavillo Education Association is eliminated due to the elimination of the Garnavillo Community School District pursuant to the merger. The description

of the former Guttenberg Education Association unit is amended to reflect the changes which have occurred over time, so that the unit of employees of the Clayton Ridge Community School District which is represented by the Clayton Ridge Education Association is described as:

INCLUDED: All certified teachers, guidance counselors, librarians, and school nurse.

EXCLUDED: Superintendent, principals, secretaries, custodians, cooks, bus drivers, teacher's aides, and all others excluded by Section 4 of the Act.

Now on this 9th day of July, 1975, the Board being advised that an election was conducted on May 23, 1975, pursuant to order of the Public Employment Relations Board and that Garnavillo Education Association, an employee organization, received an affirmative vote of a majority of employees in the bargaining unit, and the Board having further found that the aforesaid employee organization has fully complied with all regulations of the Public Employment Relations Act and the rules and regulations thereunder,

IT IS HEREBY ORDERED BY THE BOARD that Garnavillo Education Association, should be and hereby is designated and certified by this Board to be the exclusive bargaining representative for the employees of Garnavillo Community School District, a public employer, in the following bargaining unit:

INCLUDED: All full-time and regular part-time classroom teachers, (basic curriculum courses, vocational courses, fine arts courses, remedial courses, special education courses); guidance counselors, librarians, nurses, and industrial relations coordinator.

EXCLUDED: Secretaries, cooks, bus drivers, janitors, principals, superintendents, and all other employees excluded by Section 4 of the Act.
