ORDER OF RECERTIFICATION

Following the filing of an order directing an election, the Public Employment Relations Board (Board) conducted a retention and recertification election pursuant to Iowa Code section 20.15(2). The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying Clinton Education Association as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election were filed as provided for in Iowa Code section 20.15(4) and PERB rule 621—5.4, and no postelection challenges were filed pursuant to PERB subrule 621—5.2(1)(b)(2) and PERB rule 621—5.6(8). Therefore, the Board finds that an order of recertification should be issued.



INCLUDED: Classroom teachers, including but not limited to those with the following titles: Department Head, Special Education teachers, Specific Learning Disabilities teacher, Supportive Reading teachers, Audio-Visual Director, Librarians, Guidance Counselors, and Nurses.

EXCLUDED: Superintendent, Director of Administration, curriculum Director, Consultant K-9, Director of Adult Education, Athletic Director, Principals, Assistant Principals, Elementary Art and Music Coordinators, non-professional employees, and all other persons excluded by Section 4 of the Act.
