ORDER OF CERTIFICATION


NOW on this 23rd day of March 1976, the Board being advised that an election was conducted pursuant to Order of the Board, and that Association of Water Works Employees of Council Bluffs, Inc. an employee organization, received an affirmative vote of the majority of employees in the bargaining unit, and the Board having further found that the employee organization has fully complied with all regulations of the Act and the rules and regulations thereunder,

IT IS HEREBY ORDERED BY THE BOARD that Association of Water Works Employees of Council Bluffs, Inc. should be, and hereby is, designated and certified by this Board to be the exclusive bargaining representative for the employees of Board of Water Works Trustees, City Water Works, City of Council Bluffs, Iowa, a public employer in the following bargaining unit:

INCLUDED: All employees of the Council Bluffs City Water Works working in the following categories: Production Dept.: Mechanics, Maintenance man, Janitors, Utility Workers; Distribution Dept.: Maintenance man, Utility Servicemen, Utility Workers; Purification Dept.: Plant Operators, Instrument Technician; Customer Service Dept.: Clerks, Meter Repairmen, Meter Servicemen, Meter Readers, Cashiers; Business Dept.: Clerk, Storekeeper.

EXCLUDED: Members of the Water Board General Manager, Production Manager, Purification Manager, Distribution Manager, Customer Service Manager, Business Manager, Ass't. Distribution Manager, Ass't Production Manager, Ass't Business Manager, Ass't Customer Service Manager, Ass't Purification Manager, and Confidential Secretary to General Manager and those excluded by Section 4 of the Act.
