AMENDMENT OF CERTIFICATION



ORDER OF CERTIFICATION


NOW, on this 11th day of December, 1979, the Board being advised that an election was conducted pursuant to Order of the Board, and that a majority of the ballots were cast for Communications Workers of America Local No. 7174, an employee organization; and the Board being further advised that said employee organization has complied with all requirements of the Act and the rules and regulations thereunder;

IT IS HEREBY ORDERED that Comm. Workers of America, Local No. 7174 should be, and hereby is, designated and certified by this Board to be the exclusive bargaining representative for the employees of the Sioux City Public Library, a public employer, in the following bargaining unit:

INCLUDED: All employees of the Sioux City Public Library including librarians, library clerical assistants, clerks, bookmobile driver, custodians, Bookmobile Branch Manager, Morningside Librarian Assistant II.

EXCLUDED: Library director; director's secretary, Clerk Steno III; director's secretary, Clerk I; community relations specialist, Library Assistant II; assistant director, operations, Library III position; assistant director, support, Assistant Librarian III position; head of technical services, a Librarian II position; head of circulation, a Library Assistant I position; head of information, operations, a Librarian II position; the Morningside branch manager, a Librarian III position; and all senior aides funded by an agency of the federal government; Branch Managers; and all others excluded by Section 4 of the Act.
