AMENDMENT OF CERTIFICATION

The Communications Workers of America Local 7103 filed a petition for amendment of certification with the Public Employment Relations Board (PERB) seeking to amend its certification as the representative of two bargaining units of Woodbury County employees. The petition proposes the amendment of the certification to reflect the substitution of a new local, Communications Workers of America Local 7177, as the representative of those units.

A public notice of the PERB's proposed decision to grant the requested amendment was issued and posted in accordance with PERB subrule 621-4.8(2). No objections to the proposed decision were filed within the time specified in that notice.

IT IS THEREFORE ORDERED that the certification of the Communications Workers of America Local 7103 as the exclusive bargaining representative of the unit of all civilian process

servers and detention officers (jailers), as set out in PERB Case No. 8034, and the unit of all deputy sheriffs (third, second, first class, senior and master) and sergeants, as set out in PERB Case No. 8050, is hereby amended. The composition of both units remains unchanged while the certified representative will hereafter be identified as the Communications Workers of America Local 7177.

ORDER OF CERTIFICATION

Upon a petition duly filed in accordance with Iowa Code section 20.14 and PERB rule, a representative certification election was conducted herein under the direction and supervision of the Board. The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the valid ballots were cast in favor of the affected bargaining unit's representation by Communications Workers of America Local 7103, that no objections to the election were filed as provided for in Iowa Code section 20.15 and PERB rule, and that the employee organization has complied with the relevant requirements of Iowa Code section 20.25.

IT IS THEREFORE ORDERED that Communications Workers of America Local 7103 is hereby designated and certified as the exclusive bargaining representative of the following bargaining unit of employees of Woodbury County:

INCLUDED: All deputy sheriffs (third, second, first class, senior and master) and sergeants.

EXCLUDED: Sheriff, supervisory sheriffs deputies, jail commander, jail supervisors, civilian process servers, detention officers (jailers), all other employees of Woodbury County and those excluded by Iowa Code section 20.4.
