A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.


IT IS THEREFORE ORDERED that the bargaining unit of employees of the City of Davenport, initially determined in PERB Case No. 27, and the certification of Davenport Association of Professional Fire Fighters, is amended to read as follows:

INCLUDED: All fire fighters, engineers, lieutenants and captains.

EXCLUDED: Chief, assistant chief, district chiefs, fire marshall, others persons excluded by Section 4 of the Act and all other employees of the City of Davenport.

ORDER OF RECERTIFICATION

Following the filing of an order directing an election, a retention and recertification election pursuant to Iowa Code section 20.15(2) was conducted under the supervision of the Board. The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying Davenport Association of Professional Fire Fighters as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election having been filed as provided for in Iowa Code section 20.15(4) and PERB rule 621-5.4, the Board finds that an order of recertification should be issued.


IT IS THEREFORE ORDERED that Davenport Association of Professional Fire Fighters is hereby recertified as the exclusive bargaining representative of the following bargaining unit of employees of City of Davenport:

INCLUDED: All fire fighters, engineers (chauffeurs), alarm operators, records clerk, lieutenants and company captains.

EXCLUDED: Chief, assistant chief, district chiefs, captain-training officer, captain-fire marshall, other persons excluded by Section 4 of the Act and all other employees of the City of Davenport.
