ORDER OF RECERTIFICATION

Following the filing of an order directing an election, the Public Employment Relations Board (Board) conducted a retention and recertification election pursuant to Iowa Code section 20.15(2). The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying AFSCME Iowa Council 61 (Para-Educators) as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election were filed as provided for in Iowa Code section 20.15(4) and PERB rule 621-15.4 and no postelection challenges were filed pursuant to PERB subrule 15.2(4). Therefore, the Board finds that an order of recertification should be issued.


IT IS THEREFORE ORDERED that AFSCME Iowa Council 61 (Para-Educators) is hereby recertified as the exclusive bargaining representative of the following bargaining unit of employees of Davenport Community School District:

INCLUDED: All educational aides, including all educational aides in classifications I, II, III, Teacher clerical aides, library clerical aides, special education program aides, and vocal music accompanists.

EXCLUDED: Temporary employees, any employee of the Davenport Community School District that is covered under another collective bargaining agreement with the District, all administrative personnel of the District and all other employees excluded under Section 20.4 of the Iowa Public Employment Relations Board Act.

Community School District, described in PERB Case No. 2323 and subsequently amended in PERB Case Nos. 4589 and 5731, is hereby amended. The composition of the unit remains unchanged while the certified representative will hereafter be identified as AFSCME Iowa Council 61.





ORDER OF CERTIFICATION


