ORDER OF RECERTIFICATION

Following the filing of an order directing an election, a retention and recertification election pursuant to Iowa Code section 20.15(2) was conducted under the supervision of the Board. The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying IAMAW Local Lodge 254 as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election having been filed as provided for in Iowa Code section 20.15(4) and PERB rule 621-5.4, the Board finds that an order of recertification should be issued.

IT IS THEREFORE ORDERED that IAMAW Local Lodge 254 is hereby recertified as the exclusive bargaining representative of the following bargaining unit of employees of Des Moines Public Library:


INCLUDED: All non-professional employees of the Public Library of Des Moines, including Clerk; Intermediate Clerk, Senior Clerk; Intermediate Clerk-Typist, Senior Clerk-Typist, Custodial Worker; Off-set Equipment Operator, and Page.

EXCLUDED: Administrative Secretary, Senior Building Custodian; Senior Librarian; Senior Librarian; Supervising Librarian, Administrative Assistant, Coordinator of Extension Services, Director, Students working 20 hours/week or less; all employees included in the professional bargaining unit; and all others excluded by the Act.
