ORDER OF RECERTIFICATION

Following the filing of a direction of election, a retention and recertification election was conducted under the supervision of the Board. The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the eligible voters voted in favor of retaining and recertifying Eldora-New Providence Education Association as the exclusive bargaining representative of the bargaining unit described on the next page.

No objections to the election having been filed as provided for in Iowa Code section 20.15(4) and PERB rule 621—5.4, the Board finds that an order of recertification should be issued.

Said stipulation having been tentatively approved by the Board and the Board having no objections,


ORDER
