ORDER OF RECERTIFICATION

Following the filing of an order directing an election, a retention and recertification election pursuant to Iowa Code section 20.15(2) was conducted under the supervision of the Board. The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying Emmetsburg Education Association as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election having been filed as provided for in Iowa Code section 20.15(4) and PERB rule 621-5.4, the Board finds that an order of recertification should be issued.

IT IS THEREFORE ORDERED that Emmetsburg Education Association is hereby recertified as the exclusive bargaining representative of the following bargaining unit of employees of Emmetsburg Community School District:

INCLUDED: K-12 certified classroom teachers, (senior high, junior high, elementary, special elementary, and special education teachers), guidance counselors, certified nurses and librarians.

EXCLUDED: Superintendent, Assistant Superintendent, Principals (elementary and secondary), Athletic Director; teacher's aides and nurses who are not certified to teach; janitors, clericals, transportation personnel, cafeteria personnel; all other employees not specifically included and others excluded by Section 4 of the Act.

ORDER



should be and hereby is designated and certified by this Board to be the exclusive bargaining representative for the employees of Emmetsburg Community School District


