ORDER OF RECERTIFICATION

Following the filing of an order directing an election, a retention and recertification election pursuant to Iowa Code section 20.15(2) was conducted under the supervision of the Board. The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying Green Hills Area Education Agency Education Association as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election having been filed as provided for in Iowa Code section 20.15(4) and PERB rule 621-5.4, the Board finds that an order of recertification should be issued.

IT IS THEREFORE ORDERED that Green Hills Area Education Agency Education Association is hereby recertified as the exclusive bargaining

representative of the following bargaining unit of employees of Green Hills Area
Education Agency:

INCLUDED: All full-time and part-time employees of Green Hills Area Education Agency whose job assignment requires state certification by the Iowa Board of Educational examiners or holding a Statement of Professional Recognition.

EXCLUDED: All employees excluded by the Public Employment Relations Act, all non-certified employees including Directors, Supervisors and Administrators.

AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

A combined petition for amendment of bargaining unit and amendment of certification was filed with the Public Employment Relations Board pursuant to PERB rules 621-4.6 and 621-4.8. The petition results from the reorganization of the Area Education Agency 13 and the Green Valley Area Education Agency #14 into the Green Hills Area Education Agency, the renaming of the Area Education Agency 13 Education Association as the Green Hills Area Education Agency Education Association, the elimination of the Green Valley Area Education Agency #14 Professional Staff Association and the parties' desire to amend the description of the bargaining unit employed by the Area Education Agency 13, into which employees of the Green Valley Area Education Agency #14 are accreted pursuant to Iowa Code section 273.22(2), and

which will thereafter be employed by the Green Hills Area Education Agency.

A public notice of PERB's proposed decision to grant the requested amendments was issued and posted in accordance with PERB rules. No objections to the proposed decision were filed within the time specified in such notice and the Green Hills Area Education Agency Education Association has complied with the relevant requirements of Iowa Code section 20.25.

IT IS THEREFORE ORDERED that the certification of the Area Education Agency 13 Education Association as the exclusive bargaining representative for certain employees of the Area Education Agency 13, issued in PERB Case No. 780 and amended in PERB Case No. 1111, is hereby amended to reflect its successor, the GREEN HILLS AREA EDUCATION AGENCY EDUCATION ASSOCIATION, as the certified bargaining representative for the following-described unit of employees of the Green Hills Area Education Agency, the successor to Area Education Agency 13 and Green Valley Area Education Agency #14. The Green Valley Area Education Agency #14 Professional Staff Association, certified in PERB Case No. 1725, will no longer exist as the certified employee organization.

IT IS FURTHER ORDERED that the description of the bargaining unit of employees of the Area Education Agency 13, originally determined in PERB Case No. 780 and amended in PERB Case No.

1111, and now represented by the Green Hills Area Education Agency Education Association, is amended to provide:

INCLUDED: All full-time and part-time employees of Green Hills Area Education Agency whose job assignment requires state certification by the Iowa Board of Educational Examiners or holding a Statement of Professional Recognition.

EXCLUDED: All employees excluded by the Public Employment Relations Act, all non-certified employees including Directors, Supervisors and Administrators.

DECISION AND ORDER ON AMENDMENT OF BARGAINING UNIT

Upon a petition duly filed under Sections 13 and 14 of the Public Employment Relations Act, the parties waived hearing and filed with the Public Employment Relations Board a Stipulation of Bargaining Unit.

Said Stipulation having been tentatively approved by the Board and posted in conformance with the Board's Rules and Regulations, and no objections having been filed thereto, and the Board having no objections, the Board finds:

1. The Employer is a public employer within the meaning of Section 3.1 of the Act.
2. The Petitioner is an employee organization within the meaning of Section 3.4 of the Act.
3. The following constitutes a unit appropriate for the purposes of collective bargaining within the meaning of Section 13.2 of the Act:

INCLUDED: All certificated employees whose job assignment requires state certification from the Iowa Department of Public Instruction including teachers, instructors, clinicians, psychologists, consultants, audiologists, therapists, social workers, nurses, coordinators, and media specialists.

EXCLUDED: Clerks, film inspectors, aides, drivers, secretaries, printers, receptionists, production coordinators, maintenance persons, audiometrists, librarians, and all employees excluded by Section 4 of the Act, consisting of administrator, directors, assistant directors, supervisors, specialists, executive secretary, and community relations person.


Upon the basis of the foregoing, the Board hereby issues the following:

ORDER


IT IS HEREBY ORDERED that the bargaining unit determined in PERB Case No. 1725 be amended as set forth above.
