ORDER OF RECERTIFICATION

Following the filing of an order directing an election, a retention and recertification election was conducted under the supervision of the Board pursuant to Iowa Code section 20.15(2). The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying IBEW, Local 204, as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election having been filed as provided for in Iowa Code section 20.15(4) and PERB rule 621—5.4, the Board finds that an order of recertification should be issued.

IT IS THEREFORE ORDERED that IBEW, Local 204 is hereby recertified as the exclusive bargaining representative of the following bargaining unit of employees of the Atlantic Municipal Utilities:

INCLUDED: Water Treatment Plant Operator, Line Worker, Line Crew Leader, Electric Service Crew Leader, Customer Service Representative, Chief Control Operator (Electric), Materials and Safety Coordinator, Loop Maintenance Technician, Water Service Crew Leader, Data Entry Operator A, Clerk and Data Entry Operator B, System Operator (Electric), Water Service Technician, Customer Meter Records and Meter Reading Coordinator, Cashier and Customer Credit Clerk, Engineering Technician, Meter Reader, Electric Meter and Relay Technician, Plant Maintenance, General Line Supervisor, and Administrative Clerk.

EXCLUDED: Management Personnel, and Executive Secretary.


IT IS THEREFORE ORDERED that the bargaining unit previously determined in Case No 4769, and the certification of IBEW, Local 204, is amended to read as follows
