AMENDMENT OF UNIT CERTIFICATION

Upon a petition for amendment of certification duly filed under §§ 13 & 14 of the Public Employment Relations Act and Rule 4.6 of the Public Employment Relations Board's Rules and Regulations, the parties waived hearing and filed with the Public Employment Relations Board a stipulation of amendment of certification.


Said stipulation having been tentatively approved by the Board and the Board having no objections;

ORDER

IT IS HEREBY ORDERED that the bargaining unit previously determined in Case No. 430 and amended in Case No. 1919 and the certification of Keystone Education Association in that case be and hereby is amended to read as follows:

- INCLUDED: CITY BARGAINING UNIT - All full-time and regular part-time employees, employed by the employer including employees in the following departments: Street Department, Water Department, Waste Water Disposal Department, Meter Readers, and all physical workers.
UTILITY BARGAINING UNIT - All full-time and regular part-time employees, employed by the employer including employees in the following departments: Municipal Utility, Power Plant, Line Crew, Meter Readers, and all physical workers.
- EXCLUDED: CITY BARGAINING UNIT - All employees excluded by the Act in Section 4 and all other employees, including Water and Sewer Department WORKING Foreman and Street Department WORKING Foreman.
UTILITY BARGAINING UNIT - All employees excluded by the Act in Section 4 and all other employees, including Line Department WORKING Foreman and Electric Light Plant Superintendent.

ORDER AMENDING CERTIFICATION

On January 26, 1976, Local 55, IBEW, (Union) was certified as exclusive bargaining representative by the Board for the following unit

INCLUDED All full-time and regular part-time employees, employed by the employer including employees in the following departments: Municipal Utility, Power Plant, Line Crew, Street Department, Water Department, Waste Water Disposal, Meter Readers and all physical workers.

EXCLUDED All employees excluded by the Act in Section 4 and all other employees, including Line Department Line Foremen, Electric Line Plant Superintendent, Water and Sewer Department Foreman and Street Department Foreman.

On November 8, 1977, a referendum election was held pursuant to Section 397, 1977 Code of Iowa. The referendum established a Utility Board for the Vinton Municipal Electric Utility, effective December 1, 1977, with complete managerial authority, pursuant to Chapter 397.

Thereafter, on February 17, 1978, the three parties filed a combined petition, requesting the Board to amend the Union's certification to reflect the Utility Board as employer of the employees of the utility, and to separate that unit from the

previously established city unit.

Therefore, pursuant to that referendum, and at the joint request of all parties,

IT IS HEREBY ORDERED THAT Local 55, International Brotherhood of Electrical Workers is hereby certified as exclusive bargaining representative for the following employees of the City of Vinton

INCLUDED All full-time and regular part-time employees, employed by the employer including employees in the following departments Street Department, Water Department, Waste Water Disposal Department, Meter Readers and all physical workers.

EXCLUDED All employees excluded by the Act in Section 4 and all other employees, including Water and Sewer Department Foremen and Street Department Foreman.


Similarly, Local 55, International Brotherhood of Electrical Workers is hereby certified as exclusive bargaining representative for the following employees of the Vinton Municipal Electric Utility.

INCLUDED All full-time and regular part-time employees, employed by the employer including employees in the following departments Municipal Utility, Power Plant, Line Crew, Meter Readers and all physical workers.


EXCLUDED All employees excluded by the Act in Section 4 and all other employees, including Line Department Line Foreman and Electric Light Plant Superintendent.

IT IS FURTHER ORDERED that the original certification issued in Case No. 553 be amended to reflect the above changes


