
IT IS HEREBY ORDERED that Monticello, Iowa, City Employees Bargaining Association, should be, and hereby is, designated and certified by this Board to be the exclusive bargaining representative for employees of the City of Monticello, a public employer, in the following bargaining unit:

INCLUDED: All full and regular part-time employees in the following departments - streets, sanitation, water and waste water, custodial, parks, ambulance and cemetery.

EXCLUDED: All employees of the police and fire departments, library, all confidential employees of city clerk's office, manager/supervisor of ambulance services, all seasonal employees, all non-regularly scheduled part-time employees and all others excluded by Chapter 20, Section 4 of the Public Employment Relations Act
